REGULAR SESSION

The meeting convened at 12:15 pm in Closed Session.

The meeting reconvened at 12:35 pm in Open Session, joined by Martin Fox, Esq. No action was taken by the Board in Closes Session.

After review, the Minutes of the February 23, 2017 meeting were unanimously approved upon motion by Trustee Swope with a second by Trustee Schaiman. Similarly, after review, the Report of Expenses for Period 8 (February, 2017) was unanimously approved upon motion by Trustee Schaiman with a second by Trustee Swope.

Next, Mr. Gurthet reported to the Board about his recent attendance at the annual spring California Council of County Law Libraries conference in Sacramento, and brought to the Board's attention the latest legislative efforts of CCCLL. He also proposed implementing a monthly wireless charge on patrons. Upon consideration, the Board unanimously decided against such charge on the basis that it would not generate much additional income for the Law Library.

Next, Mr. Gurthet and Trustee Copenhagen reported on the most recent efforts of the San Mateo County Law Library Foundation. Considerable discussion ensued regarding a potential speaker for the upcoming May 2017 fundraising event. Finally, Mr. Gurthet reported on the latest potential County funding for the Law Library.

Next, Trustee Jacquelyn Brown in her capacity as liaison to the San Mateo County Bar Association reported that the Family Law Section of the Bar was considering a system utilizing the Law Library to print Family Law Court orders. Mr. Gurthet and the Board were open to the Family Law Sections proposal and agreed that further discussions should commence.

The meeting concluded with public comment by Mr. Fox regarding potential usage of the Law Library conference room for the Stepping Up Initiative. Trustee Schaiman made motion made to adjourn, Trustee Swope seconded and meeting adjourned unanimously at 1:10 pm.

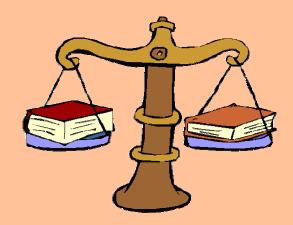

SUPPORTING THE LAW LIBRARY'S MISSION: TO ENSURE CONTINUED ACCESS TO JUSTICE FOR ALL PEOPLE

Welcome to the San Mateo County Law Library Foundation newsletter from the members of the Law Library Foundation that covers the ongoings of the San Mateo County Law Library and events in the legal community.

As part of our first issue, we interviewed Andrew Gurthet, the Director of the Law Library about his perspective on the importance of the Law Library's success in our community.

Q&A WITH ANDREW GURTHET

Q: During your tenure as the Director of the Law Library, who do you see using the library's resources?

A: The vast majority of Law Library users fall into two categories, attorneys and the general public. In regards to the attorneys, most are local, solo or small-firm attorneys who do not have legal materials available to them in their office. We do, however, get large-firm attorneys from time to time. Most come in while on break from a case across the street in the Superior Court.

In regards to the general public, the vast majority are individuals who cannot afford an attorney and are representing themselves pro per in court. Unlike an academic or corporate law library, almost all the questions by patrons in the San Mateo County Law Library are procedural in nature.

Q: What programs and resources are being used most often?

A: Our Lawyer in the Library (which offers one-on-one legal assistance on a given topic once a month) is very popular as well as our monthly free lectures.

I wish we had the capability and capacity to expand both of these programs. In regards to resources, the most used are those related to California legal issues, such as those titles published by West Group, CEB, LexisNexis-Matthew Bender, and Nolo Press.

Q: What appears to be the most pressing needs that the Law Library currently faces?

A: The Law Library used to offer evening and weekend hours to patrons. Now, however, we close at 5pm Monday through Friday and are not open on the weekends. This has caused a tremendous drop in usage of the Law Library. Now, attorneys who wish to work in the evenings can no longer use the Law Library. Also, members of the general public who work during normal work hours cannot use the Library after work or on the weekend.

Additionally, due to the drastic drop in income from filing fees over the past 5+ years, almost 70% of the print collection and 30% of the electronic collection have been cut. There are now areas of the law, such as tax law, bankruptcy, federal civil rights, immigration law, etc. in which the Law Library has no current print or electronic materials for patrons.

WHAT IS THE SAN MATEO COUNTY LAW LIBRARY FOUNDATION?

Due to budget cuts and rising costs, the Law Library faces a financial crises. In response, it has made substantial cuts to the collection of legal resources and operating expesnes.

The San Mateo County Law Library Foundation was created in 2016 by a small group of local attorneys and professionals committed to help raise funds to keep the Law Library doors open. The Law Library Foundation strives to return the Law Library to its posistion of vibrancy, meeting the needs of the legal community and others throughout San Mateo County. We are also exploring way sto restructure funding at the state level and to secure funding from the County of San Mateo for this essential resource. Thank you fo helping us keep the Law Library strong, vital and accessible to those in need.

WHAT'S NEXT?

In the past two years, due to budget cuts, the Law Libray has had to reduce its expenditures by 32%. This has resulted in a drastic reduction in many of the Law Libray's resources, including, cutting operating hours by 18 hours per week.

The Law Library Foundation will advocate and get the word out to friends, family, and most importantly, to local legislators, that the Law Library is in financial crises and in need of help. Ultimately, the Law Library Foundation hopes to restore the resources that have been cut, including, but not limited to, updates to the online resources, ordering updated print materials, increasing staff and restoring evening and weekend operating hours.
