REGULAR SESSION

The meeting convened at 12:15 pm in Closed Session. The meeting re-convened at 12:25 pm in Open Session, joined by Martin Fox, Esq. Mr. Gurthet reported that the Board in Closed Session had unanimously approved the promotion of Caroline Bracco to Assistant Director with a pay raise to reflect her new position.

After review, the Minutes of the May 25, 2017 meeting were unanimously approved upon motion by Trustee Schaiman with a second by Trustee Foiles. Similarly, after review, the Report of Expenses for Period 11 (May, 2017) was unanimously approved upon motion by Trustee Schaiman with a second by Trustee Groom.

Next, Mr. Gurthet gave a brief update of recent activities of the Law Library Foundation, most notably their recent efforts to raise funds via potential large donors and grants. Next, the Board reviewed the proposed budget for Fiscal Year 2017-2018. The Board unanimously approved the budget upon motion by Trustee Copenhagen with a second from Trustee Schaiman. Finally, Trustee Groom reported that the County is still working on potentially partially funding the Law Library per the request of Mr. Gurthet for Fiscal Year 2017-2019.

Trustee Jacquelyn Brown in her capacity as liaison to the San Mateo County Bar Association reported that there has been no further activity regarding the Law Library by SMCBA .

Next, Mr. Fox provided public comment and requested that the Board look into Joint Power Authority efforts with other county law libraries. Upon this recommendation, Mr. Gurthet reported that the Law Library is exploring such an effort to combine catalog systems with both Contra Costa County Law Library and Alameda County Law Library, and potentially also San Diego County Law Library and Sacramento County Law Library.

Prior to adjournment, Trustee Copenhagen announced that she would no longer be able to serve as a Trustee going forward due to her upcoming move to the Boston Area. Trustee Schaiman then made motion to adjourn, Trustee Copenhagen seconded and meeting adjourned unanimously at 1:05 pm.



GRANTS AUTHORIZED: Reflects all grants to qualified organizations that have been recommended by the donor and approved by Silicon Valley Community Foundation. If the grant is scheduled for payment on a future date, it will also appear in the Restricted Assets section as Grants Payable, reducing the balance available for granting.

GRANTS PAYABLE: Grants that have been approved, but are scheduled for payment on a future date.

ILLIQUID ASSETS: Donated property that has not been sold.

INTERFUND GIFTS: Transfers to your fund from another fund at Silicon Valley Community Foundation. INTERFUND GRANTS: Transfers from your fund to another fund at Silicon Valley Community Foundation.

INVESTMENT RETURNS: Reflects the total return in the investment pool, net of investment management fees.

OTHER ADDITIONS: Deposits to your fund that do not represent a gift, i.e. partnership income, dividends/interest earned on

gifted securities, other assets received in exchange for goods or services.

OTHER EXPENSES: Administrative expenses paid from your fund, i.e. legal, consulting and credit card processing fees.

Investment Information

Fund returns are net of investment fees and expenses. Periods greater than one year are annualized. This Fund's Benchmark is a composite policy benchmark return weighted by the fund's allocation to an investment pool. Each policy benchmark is comprised of market index returns weighted by the pool's strategic asset allocation target. Comparison to the benchmark is not appropriate if the fund's allocation changed during the performance period, or if the fund includes assets outside of the SVCF pools. Investment Pool Allocation Guidelines

Long-Term Growth: For funds seeking maximum growth. Appropriate for funds distributing less than 7% annually or that portion of a fund that can tolerate volatility and will remain invested for at least seven years to realize growth opportunities.

Social Impact: For funds seeking maximum growth from companies with strong financial and social records. Appropriate for that portion of a fund that can tolerate volatility and will remain invested for at least seven years to realize growth.

Balanced: For funds seeking more moderate levels of growth and risk. Appropriate for funds distributing over 7% annually or that portion of a fund that will remain invested for at least three years to realize return objectives.

Short-Term: For funds seeking above money market returns and can tolerate some volatility. Appropriate for funds or that portion of a fund to be distributed in one to two years.

Capital Preservation: For funds seeking stability, or the portion of a fund to be distributed within 1 year.
